#### 1 The Trust and its Operations

The Trust was formed on November 3, 2006 as Mian Muhammad Bukhsh Trust under the Seal of Registrar Joint stock companies, Jehlum. It commenced its operations in July 2007. The Trust is engaged in providing free medical facilities to deserving rural population of Jehlum river basin.
